# Privacy Policy - ropox Scripting Commissions

## 1. Introduction

ropox ("Provider"), an individual freelancer based in the Republic of Turkey, is committed to protecting the privacy of its clients ("Clients") in connection with Roblox scripting commission services ("Services"). This Privacy Policy explains how the Provider collects, uses, stores, and protects personal data in compliance with Turkey's Personal Data Protection Law (KVKK, Law No. 6698) and other applicable regulations. By engaging the Services, Clients consent to the practices described herein.

## 2. Data We Collect

The Provider may collect the following personal data from Clients:

- **Contact Information**: Discord username, email address, or other communication details provided via Discord DMs.
- **Project Information**: Project requirements, game files (.lua, .rbxl), and related assets submitted for the Services.
- **Payment Information**: Bank account details (for wire transfers), Roblox account details (for Robux payments), or cryptocurrency wallet addresses (for ETH payments).
- **Usage Data**: Information about Client interactions with the Provider, such as communication logs or project progress updates.

# 3. Purpose of Data Collection

The Provider collects and processes personal data for the following purposes:

- To provide and deliver the Services, including scripting, project development, and integration.
- To communicate with Clients regarding project updates, inquiries, or revisions.
- To process payments and fulfill financial obligations.
- To maintain records for future reference or conflict resolution, as outlined in the Terms of Service.
- To comply with legal obligations under Turkish law or other applicable regulations.

## 4. Data Storage and Security

• **Storage**: Personal data is stored securely on encrypted devices or cloud services accessible only to the Provider.

- **Security Measures**: The Provider implements reasonable technical and organizational measures to protect data against unauthorized access, loss, or disclosure, including 2 factor authentication password managers and secure communication channels.
- **Retention**: Data is retained indefinitely for record-keeping and potential future project needs unless the Client requests deletion in writing, subject to legal requirements.

## 5. Data Sharing

The Provider does not sell or share personal data with third parties except:

- With third-party service providers (e.g., banks, Roblox, cryptocurrency platforms) solely to process payments or deliver the Services.
- When required by law or to comply with legal processes (e.g., court orders).
- With the Client's consent, such as under a non-disclosure agreement (NDA). The Provider ensures that any third parties involved comply with applicable data protection standards.

#### 6. Client Rights

Under the KVKK and other applicable laws, Clients have the right to:

- Access their personal data held by the Provider.
- Request correction of inaccurate or incomplete data.
- Request deletion of their data, subject to legal retention obligations.
- Object to the processing of their data for specific purposes.
- Lodge a complaint with the Turkish Personal Data Protection Authority (KVK Kurumu) if they believe their rights have been violated. To exercise these rights, Clients may contact the Provider via Discord DMs.

#### 7. Third-Party Platforms

The Services involve interactions on third-party platforms, such as Discord and Roblox, which have their own privacy policies. The Provider is not responsible for the data practices of these platforms. Clients are encouraged to review the privacy policies of Discord, Roblox, and any payment processors used.

#### 8. Amendments

The Provider may update this Privacy Policy to reflect changes in legal requirements or business practices. Updates will be communicated to Clients via Discord DMs with a 7-day notice period before taking effect.

## 9. Contact

For questions, requests, or concerns about this Privacy Policy or data practices, contact the Provider via Discord DMs. Privacy-related agreements may be executed by their legal guardian where required by law.

# **10. Governing Law**

This Privacy Policy is governed by the laws of the Republic of Turkey. Any disputes arising hereunder shall be subject to the exclusive jurisdiction of Turkish courts.
